DIRECTIONS FOR USE: PreCede Canola should be used based on soil analyses in accordance with the recommendation of a qualified person or institution such as a certified crop consultant, agronomist, or university crop extension publication, or apply according to recommendations in your approved nutrient plan.

General application rate is 9.2 fl oz/100 lbs of seed.
