**GENERAL INFORMATION:** Convey™ RxZn is a liquid fertilizer. Convey RxZn is designed to address zinc deficiency.

**DIRECTIONS FOR USE:** Convey RxZn should be used based on soil and tissue analyses in accordance with the recommendation of a qualified person or institution such as a certified crop consultant, agronomist, or a university crop extension publication.

**General application rate is 2 quarts/acre.**

**COMPATIBILITY:** Tank mix compatibility is impacted by water quality which may vary by location. When mixing, always ensure adequate dilution in the spray tank before adding Convey RxZn. A standard jar test is recommended prior to mixing with other fertilizers or pesticides.

**STORAGE AND DISPOSAL:** Product is stable, non-flammable and non-explosive. **DO NOT FREEZE.** If spillage occurs, soak up with an inert substance. Dispose of this product in accordance with federal/state/county regulations. Store this product in a tightly closed original container in a well-ventilated place.
